[HW v WW \[2021\] EWFC B20](#): A notable case presided over by HHJ Kloss, addressing Covid-19 as a potential Barder event for revisiting financial orders.

[Rotenberg v Rotenberg & Ors \[2024\] EWFC 185](#): A case before Mr Justice Peel, where the judge struck out the applicant's claims, confirming the existence of the Thwaite jurisdiction and concluding high court proceedings that had been ongoing since 2013.
